

Regulations for the provision of electronic services by Grupa SKB Sp. Z o.o. § 1

General provisions

1. These Regulations define the scope and conditions for the provision of electronic services by Grupa SKB Sp. z o.o. with headquarters in Warsaw at ul. Chorągwi Panczernej 82A, (postal code: 02- 951), with the assigned KRS number 0000642109, REGON 365642690, NIP 5272782752, e-mail address: kontakt@gotowemieszkanie.pl website www.gotowemieszkanie.pl, hereinafter referred to as the "Company", in particular, the rules of using the website www.gotowemieszkanie.pl (hereinafter referred to as the "website").
2. Entering the appropriate URL of the websites administered by the user in the web browser and filling in the contact form on the website with the personal and contact details of the website user, is tantamount to full acceptance by the user of the terms of these Regulations without the need to draw up a separate agreement.

§ 2

Rules for accessing the website

1. The company ensures the operation of the ICT system in such a way that the user can use the website free of charge and start and stop using the above-mentioned data at any time. pages.
2. Access to the website is not limited, in particular, this access does not require registration or logging in.
3. Contacting the Company via the website is possible using the contact form available on the website, by filling in the individual fields of the contact form with the necessary personal data (name, e-mail address, telephone number) and indicating the subject of the conversation (inquiries).
4. The rules for saving and accessing data on the devices of users using the website for the purpose of providing electronic services by the website administrator and data entered into the ICT system used by the user (files cookies), are included in the Company's Privacy Policy, posted on the website.
5. The use of the Company's website requires that the IT systems used by website users have cookies enabled and active Javascript.

6. In order to use the website and the contact form on it, the device used by the user should meet the following technical requirements necessary for cooperation with the Company's IT system:

§ 3

Website Terms of Use

1. The User undertakes to use the website in accordance with the provisions of these Regulations and morality.
2. The User is obliged, in particular, to comply with the prohibition on the abuse of electronic means of communication and the prohibition on the provision of data and content by or to the Company's ICT systems:
 - a. causing work disturbance or overloading the IT systems of the Company or other entities directly or indirectly involved in the provision of electronic services by the Company,
 - b. inconsistent with generally applicable laws,
 - c. violating the interests of third parties, generally accepted social and moral standards or damaging to decency, offensive or violating anyone's dignity.
3. In extraordinary situations, related to the need to restore the stability of the ICT system or to carry out maintenance works on the system ICT, the Company has the right to temporarily restrict the operation of the website.
4. The Company is not responsible for any interruptions in the operation of the website or delays or disruptions in data transmission resulting from technical reasons beyond the Company's control.

§ 4

Personal data of the website user

1. The administrator of your personal data is Grupa SKB Sp. z o.o. with headquarters in Warsaw at ul. Chorałwi Panczernej 82A, (postal code: 02-951), with the KRS number 0000642109, REGON 365642690, NIP 5272782752. The company is entered in the register of entrepreneurs of the National Court Register by the District Court for the capital city of Warsaw in Warsaw, 13th Commercial Division of the National Court Register under the number 0000626475.
2. Please be advised that we process your personal data in order to handle correspondence sent via the contact form on the website; The legal basis for data processing is the implementation of our legitimate interests (as the administrator of personal data) in the form of communication with website users. In this case, your data will be processed no longer than it is necessary to answer the question asked, and after that time may be processed for the period of limitation of any claims.
3. The personal data provided by you will be processed for marketing and commercial purposes, and the legal basis for processing is, if you have given it, consent. In this case, your Personal Data will be processed until your consent is revoked, which you may withdraw at any time.
4. Please be advised that providing your data is voluntary but necessary to answer your question or send a commercial offer. You have the right to request access to your personal data, rectification, deletion or limitation of processing, as well as the right to object to the processing, as well as the right to transfer your data and submit a complaint to the supervisory body.
5. Please be advised that the personal data provided by you will not be made available for processing to third parties, in particular countries, except when we are obliged to transfer them on the basis of legal provisions.
6. All data provided by you is confidential and will be processed only for the purpose stated above. If the data were to be processed for a different purpose, we will notify you about it, thus providing you with the opportunity to object to the processing of this data by us for purposes other than the original one.

§ 5

Intellectual property

1. The rights to the content on the website are vested in the Company or third parties who have agreed to include this content on the website.
2. The User has the right to use the content of the website for personal use and only under the conditions set out in these Regulations.
3. Zamieszczone Content posted on the website, constituting the intellectual property of the Company in particular, such as text, graphics, logos, icons, images, photos, audio and video files, data files, presentations or programs may not be reproduced or distributed in any form and in any way without the prior consent of the Company.

§ 6

Complaints procedure. Reporting comments.

1. Complaints regarding the functioning of the website should be reported via the e-mail address kontakt@gotowemieszkanie.pl.
2. Complaints should be submitted within 7 days from the date of occurrence of the reason for the notification.
3. The company will consider the submitted complaint immediately, provided that it is posted in the complaint, a brief description of the problem, an indication of the time of its occurrence and data enabling the identification of the reporting user (first name and surname, e-mail address).

§ 7

Final Provisions

1. These Regulations apply from 01/05/2018.
2. The Company reserves the right to amend the provisions of these Regulations without prior notification to website users.
3. Amendments to the Regulations will be published by the Company on its website.
4. The use of the website by the user after the amendments to these Regulations have been introduced constitutes their acceptance.
